Moonen Shipyards considers your privacy very important. We will therefore process and use your data in a secure manner, entirely in accordance with the General Data Protection Regulation. In this privacy statement we explain to you what information we collect from you and why we do this. You can also read your rights regarding the processing of your personal data. When your data is processed outside of Europe, we will ensure that your privacy is properly guaranteed in accordance with your country of origin.

For what purpose and on what basis do we process personal data?

Moonen Shipyards processes your personal data for the following purposes:

- If it is necessary for the performance of an agreement;
- If it is necessary for the purpose of looking after our legitimate (commercial interests). Such as newsletters.
- If we are legally obliged to do so;

If you are a (potential) customer of us, we process your personal data for the following purposes:

- In order to send you an offer
- In order to be able to deliver goods to or carry out activities for you
- In order to send you an invoice
- To call or e-mail you if necessary to carry out our services (the processing is necessary for the execution of the agreement)

Special and/or sensitive personal data that we process:

Moonen Shipyards does not process special and/or sensitive personal data. Our website does not intend to collect data about website visitors who are younger than 16 years, unless they have permission from a parent or guardian. However, are unable to check if a visitor is older than 16. We therefore encourage parents to be involved in the online activities of their children, in order to prevent their data being collected without parental consent. If you are believe that we have collected personal information about a minor without this permission, please contact us via info@moonen.com, and we will delete this information.

Automated decision-making

Moonen Shipyards does not make decisions based on automated processing, on matters that can have (significant) consequences for people. These are decisions that are taken by computer programs or systems, without involving a person (for example, an employee of Moonen Shipyards).

Sharing your personal data with third parties

Moonen Shipyards will not sell your information to third parties and will only provide this information if this is necessary for the execution of our agreement with you, or to comply with a legal obligation. With companies that process your data on our behalf, we obtain a processor agreement to ensure the same level of security and confidentiality of your data. Moonen Shipyards remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Moonen Shipyards only uses analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website for your benefit through their use.

You can opt out of cookies by setting your internet browser so that it does not store cookies in future. In addition, you can also delete all information previously saved via the settings of your browser.

Direct mailing

If you are a customer of us or if you have expressed a specific interest in our products, we will store and use the personal data you have provided in order to inform you personally by e-mail in the future of our existing and new products and services. We have a legitimate interest in using your personal data for this purpose, namely to market and sell our products and services.

Rights with regard to your personal data

The General Data Protection Regulation has given you a number of rights with regards to the personal data you have processed by us.

- Inspection - You can request Moonen Shipyards at any time to view your details.
- Change - If you want your information to be adjusted, corrected, supplemented, protected or removed, you can submit a request for this.
- Objection - You may object to the processing of your data with the legitimate interest of Moonen Shipyards as a legal basis.
- Data transfer - If you wish to transfer your data to another provider, Moonen Shipyards will provide your data in a structured and current form that can be accessed by conventional digital systems.
- Withdrawal - When we have processed data based on your explicit consent, you have the right to withdraw this permission. This may affect the services that we can provide you.

You can send a request for access, modification, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@moonen.com.

In order to ensure that the request for access has been made by you, we ask you to send a copy of your identity document with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy.

Moonen Shipyards will respond to your request as soon as possible, but within a maximum of four weeks. Moonen Shipyards would also like to make you aware that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
